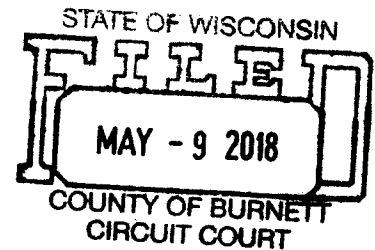


SPECIAL INSPECTION WARRANT

THE STATE OF WISCONSIN, To Burnett County Zoning Administrator, a representative of the WI DNR, and to the sheriff or any constable or any peace officer of said county;

Whereas, Jason Towne has this day complained in writing to the said court upon oath that on the 8<sup>th</sup>, day of May, 2018, in said county, in and upon certain premises in the Town of Meenon and Oakland in Burnett County and more particularly described as follows:

27225 State Road 35, Webster, WI;

Tax Id's: 13894, 13895, 13900, 13901, 11202, 11204, 11212 and 11213

There now exists the necessity to determine if the premises comply with the Burnett County Ordinances Chapter 70, and the Conditional Use Permit previously issued to the premises. Regarding installation and maintenance of sewer and discharge of camper unit waste water and prayed that a special inspection warrant be issued to search said premises.

Now, therefore, in the name of the state of Wisconsin; Jason Towne, along with a representative from Burnett Co. Sheriff's Dept., if necessary, and other individuals from Burnett County Zoning, and Wisconsin DNR are commanded forthwith to search said premises including all camping units, and other recreational units located on the premises, and be allowed to open the underside of said camping units to determine whether or not any alterations have been made to the sewer discharge of said units that would result in them not discharging as required under Wisconsin Administrative Code; SPS 383.32(1)(f).

AFFIDAVIT

Jason Towne being duly sworn, states that as Zoning Administrator for Burnett County, he received a complaint for improper sewer attachments for camping units located at:


27225 State Road 35, Webster, WI, in the Town of Meenon and Oakland, Burnett County WI.

Tax Id's: 13894, 13895, 13900, 13901, 11202, 11204, 11212 and 11213

That based upon this complaint; your administrator has received information as follows:

- 1) That a Conditional Use Permit was issued for this property; expanding the property to 100 units, and that this Conditional Use Permit, and other prior Conditional Use Permits were based upon a shower and restroom facility being provided under a separate sewer system for the camping units.
- 2) That a dump station was approved in the 1990's to serve the campground, only if, the public shower and restroom facilities were provided to the camping units.
- 3) Your affiant has received information that the shower and restroom facilities have been removed, therefore, violating the Conditional Use Permit, and leading to a severely undersized dump station for the 100 unit campground.
- 4) That your affiant has further received a complaint from a previous tenant of the campground that indicated that some or all of the camping units, located on the property, were diverting waste water specifically; grey water, by altering their camping units, and discharging the grey water directly onto the ground under their camping units.
- 5) That this is a violation of the Wisconsin Administrative Code; SPS 383.32(1)(f), or campground usage.


Wherefore, Jason Towne prays that a special inspection warrant be issued to search the premises and all camping units located on the premise for alterations of the camping units that would result in the discharging of the grey water onto the ground as opposed to a properly established sewer system.
