UNIT 1 DRIVER STATED THAT AS SHE WAS DRIVING BEHIND UNIT 2 SHE HAD TO STOP BECAUSE UNIT 2 AND UNIT 1 HAD SLOWED DOWN. UNIT 2 DRIVER STATED THERE WAS A VEHICLE 2 CARS IN FRONT OF HIM THAT TURNED SUDDENLY ON HAMILTON ROAD THAT CAUSED THE VEHICLE HE WAS FOLLOWING TO SWERVE AND SLOW DOWN TO AVOID A CRASH. UNIT 2 WAS HAULING A BOAT TRAILER WITH IL REGISTRATION OF IL2326HK. AT IMPACT UNIT 1 HAD STRUCK THE REAR OF THE BOAT AND TRAILER CAUSING DAMAGE TO THE BOAT MOTOR. THE TRAILER APPEARED TO BE UNAFFECTED BY THE COLLISION.
